### Nurse Practitioner Involvement with TCPI



The National Nursing Centers Consortium (NNCC), in partnership with the American Association of Nurse Practitioners (AANP), is operating a Nurse Practitioner Support and Alignment Network (NP SAN) for the TCPI in an effort to promote nurse practitioner participation in practice transformation networks and provide for a wider representation of primary care providers to increase the TCPI's capacity to reach underserved and other vulnerable populations.

The NP SAN will recruit nurse practitioners into PTNs in the following ways:

- Reach out to NNCC's 250+ nurse-managed health center members and AANP's 50,000+ NP membership
- Promote TCPI and PTN involvement through NNCC and AANP meetings, conferences, and specialty symposia

- Share PTN enrollment information in NP SAN programming and through targeted outreach to members
- Match NPs with PTNs based on geographic area or area of expertise
- Provide ongoing educational programming and support to NPs enrolled with PTNs to ensure they remain involved with PTNs and engaged in the TCPI process

### NP SAN Educational Programming and Content

NNCC and AANP will develop educational programming and content to support NP adherence to TCPI principles as they work their way through the Phases of Practice Transformation. The NP SAN will deliver TCPI-related content through free webinars; thousands of hours of continuing education credits; annual membership conferences, specialty conferences, and training symposia; weekly and monthly newsletters; peer-reviewed journal articles; and web-based and in-person technical assistance.

NNCC and AANP will make available existing educational content to PTNs and their NP membership and will also develop new TCPI-related educational programming in coordination with PTNs and their stated needs.
